British Society of Gastroenterology

The 1988 Annual Meeting of the British Society of Gastroenterology was held at the University of Sheffield from 14-16 September 1988, under the presidency of Dr J J Misiewicz. The three day programme was a blend of tradition and innovation. There was a full programme of scientific papers, but the increasing use of the medium of poster presentation was marked by a plenary poster session; for the first time, the poster achieved parity with the spoken word. Numerous sessions catered for sectional interests within the Society, while postgraduate education was covered by the Teaching Half-Day and four State-of-the-Art lectures. The Endoscopy Foundation Lecture was, most appropriately, 'A personal history of the fibrescope' by Professor Basil Hirschowitz, and the Sir Arthur Hurst lecture was given by Professor Sir David Weatherall. Receptions were held at the Mappin Gallery, the Industrial Museum, and Chatsworth House; members and guests were serenaded during the Conference Dinner at the Cutlers Hall by the music of the Grimethorpe Colliery Brass Band.
