Book reviews. Notes

The laparoscopic colour photographs are poor in some instances and seem to be taken from the VDU screen rather than by direct photographs down the laparoscope. If the surgeon's view is as poor as some of these pictures, he would be well advised to abandon the procedure!

The claim in the promotional advertisement that the book 'leads you step by step through each operation so that you can perform these new procedures' could be quite dangerous for anything but cholecystectomy. The section on cholecystectomy, is detailed, and the pros and cons of various techniques are discussed. There is a strong emphasis on the use of disposable equipment, which makes the operations very costly. There is a useful section on how to deal with adhesions; safety aspects are carefully discussed. There is a short section on the techniques for operative cholangiography and a short account of exploring the common bile duct laparoscopically.

It is natural to compare this volume with other books on laparoscopic biliary surgery, and it does not compare favourably. It would have been better to have restricted the subject to biliary surgery and to have expanded on this and to have improved the illustrations and then it would have been a very acceptable guide. It is moderately expensive.

Inflammatory Bowel Disease. By John Lennard-Jones, Sidney Truelove, eds. (Pp 593; SWK420.) Malmo: Corona Astra, 1992.

This is a useful multidisciplinary review of the current state of play in inflammatory bowel disease. It is of more recent vintage than established books on the subject; the sections on the role of inflammatory mediators, and glycoproteins in particular, are more up to date. The first four chapters discuss the epidemiology and genetics of inflammatory bowel disease followed by a superficial treatment of the role of factors such as smoking. Immunological and other pathogenetic mechanisms such as change in intestinal permeability and mucin glycoproteins are discussed in greater detail in the next five chapters.

The latter two chapters of the book consider clinical issues. Infectious conditions are covered briefly and although aids related conditions are covered I would have liked to have seen more emphasis on this important topic. Successive chapters on the medical and surgical management of ulcerative colitis and Crohn's disease respectively cover all important management issues. The editors have worked hard to avoid repetition; I particularly liked the separate chapters on the role of steroids, salicylates, and immunosuppressive agents, which precede sections on overall medical management of inflammatory bowel disease.

The overall balance of the book is good and all areas of the clinical science and management of inflammatory bowel disease are covered adequately. I must admit to differ with another reviewer of this book who said 'Forgive the pun but I feel this book falls between two stools' and

that the limiting of the size of the book to a 'reasonably compact volume' had led to the sacrificing of detailed references and full discussion of therapeutic issues. I feel that the book's balance is about right but (as with most up to date textbooks) its currency would not last more than five years.

Gut publishes original papers, leading articles, and reviews concerned with all aspects of the scientific basis of diseases of the alimentary tract, liver, and pancreas. Case reports will only be accepted if of exceptional merit. Letters related to articles published in Gut or with topics of general professional interest are welcomed. Authors should include the names and addresses of four experts whom the authors consider suitable to peer review their work.

COMMUNICATIONS Two copies of the manuscript and figures should be addressed to the Editor, Gut, BMA House, Tavistock Square, London WC1H 9JR, UK. Manuscripts should follow the Vancouver conventions (see BMJ 1979; i: 532-5. Gut 1979; 20: 651-2). They should be in double-spaced typewriting on one side of the paper only. The title page should include the name of the author with initials or distinguishing first name only, and the name and address of the hospital or laboratory where the work was performed. The paper must include a precise summary of the work of less than 200 words. Use of abbreviation is discouraged. A separate covering letter signed by all authors must state that the data have not been published elsewhere in whole or in part and that all authors agree to publication in Gut. Previous publication in abstract form must be disclosed in a footnote. Papers must not be published elsewhere without prior permission of the Editorial Committee.

ACKNOWLEDGEMENT OF MANUSCRIPTS Manuscripts will only be acknowledged if an addressed postcard is enclosed.

ILLUSTRATIONS *Photographs* Unmounted photographs on glossy paper should be provided. Illustrations should not be inserted in the text but marked on the back with the figure numbers, title of paper and name of author. All photographs, graphs, diagrams should be referred to as figures and should be numbered consecutively in the text in Arabic numerals. The legends for illustrations should be typed on a separate sheet.

ETHICS Ethical aspects will be considered in the assessment of papers (see the Medical Research Council's publications on the ethics of human experimentation, and the World Medical Association's code of ethics, known as the Declaration of Helsinki (see *BMJ* 1964; ii: 177)).

SI UNITS All measurements except blood pressure are expressed in SI units. In tables and illustrations values are given in SI units. For general guidance on the International System of Units and some useful conversion factors, see *The SI for Health Professions* (WHO, 1977). NB: Such conversion is the responsibility of the author.

REFERENCES These follow the Vancouver system – that is, references numbered consecutively in the text and listed numerically with journal titles abbreviated in the style of *Index Medicus, Standard journal article*. List up to six authors, then add *et al*.

CORRECTIONS other than printers' errors may be charged to the author.

REPRINTS Reprints will be available on payment of the necessary costs; the number of reprints required should be sent to the Publishing Manager on the form provided with the proof.
